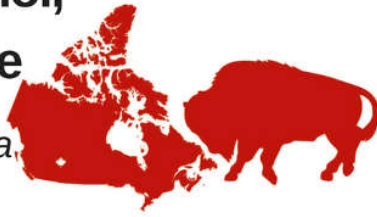


22nd International Council on Alcohol, Drugs and Traffic Safety Conference

Exhibit Rates

Exhibit fees are **\$1,750.00 per booth** (10' x 10'), plus 5% GST. Complimentary registration for one representative is included in this fee; additional exhibitor representatives will be required to register and pay the applicable full registration fee.

Exhibit fees include a carpeted booth space, one table, two chairs, one 120V power drop, and pipe and drape. All other materials/furnishings must be ordered through GES, the exclusive conference show services provider.

Cancellation Policy and Failure to Occupy Space

In the event of the committee receiving written notification on or before June 17, 2019, ICADTS shall refund the entire exhibitor payment, less an administration fee of \$500 per booth plus 5% GST. For cancellations received after June 17, 2019, the entire payment shall be forfeited by the exhibitor unless the committee is able to re-sell the booth space under similar terms and conditions, in which case the exhibitor shall only forfeit an administration fee of \$500 plus 5% GST.

In the event that space is not occupied by the close of exhibit installation, the exhibitor shall forfeit all payments.
